
Opening or Expanding Your Business in Cynthiana: An 8-Step Guide

Starting or expanding your business in Cynthiana is a rewarding process, and we're here to guide you through every step. Follow these 8 essential steps to ensure your business is compliant, well-supported, and positioned for success.

Step 1: Find a Property

Start your search for commercial property in Cynthiana by browsing available listings. You can check out local listings or contact the Cynthiana-Harrison County Chamber of Commerce for guidance.

- Have a potential location identified? Confirm zoning requirements with the Cynthiana Planning and Zoning Department: Phone: 859-234-7165, Email: office@harrisonplanning.com.



Step 2: Zoning & Permits

All businesses in Cynthiana must meet local zoning requirements. Before you begin operations, make sure your business complies with zoning laws.

Contact the Planning and Zoning Department to apply for zoning approval and a building permit to confirm that your proposed location is permitted for your intended use and aligns with regulatory requirements and your business plan.

Apply for a Building Permit

If your business involves any construction or renovations, you will need a building permit from the Cynthiana- Harrison County- Berry Joint Planning Commission. This ensures adherence to local and state construction codes as well as applicable safety standards. Please note that zoning approval and a building permit are separate requirements. Depending on the scope of your project—such as new construction, interior fit-ups, or a change in use—your business may need to obtain both. These approvals can both be processed through the Planning Department.

Please consult with the Planning Office to review applicable sign ordinances and obtain the necessary permits before purchasing or installing signage. This will help ensure compliance with local regulations and prevent unnecessary expenses on signage that may not be permitted.







Step 3: Incentives for Industrial Development

If you are looking to locate or build in Cynthiana's Business Park, you may qualify for various incentives to support development. These incentives can help reduce costs for land, infrastructure, and construction.

Step 4: Food & Beverage License

If your business involves selling food or beverages, you will need to obtain a food service permit and an alcohol license (if applicable).

 For food service permits, contact the WEDCO Health Department: Phone: (859) 234-0241, Website: www.wedcohealth.org.





(ABC) license through two governing agencies: the Kentucky Department of Alcoholic Beverage Control (state ABC) and the City of Cynthiana or Harrison County (local ABC depending on where your business is located). For those located in the city, license holders should familiarize themselves with the City's ABC ordinance. The ABC license type and fee varies with the need of each applicant.

• For alcohol licenses inside city limits,

person or business must apply for and be issued an Alcoholic Beverage Control



- For alcohol licenses inside city limits, contact the Cynthiana ABC Administrator. A city license is required. Phone: 859-234-7150, Email: autumn.terhune@cynthianaky.com.
- For alcohol licenses outside city limits, the Harrison County ABC Administrator will approve your license and no further steps are necessary.

Step 5: Taxes and Occupational Licenses

Cynthiana businesses are required to withhold a local payroll tax, and businesses must file taxes with both the City, the County, and the State of Kentucky. Make sure you're in compliance with all tax obligations.

City of Cynthiana

An Occupational license is required by any entity or individual doing business in the City. This includes, but is not limited to, landlords, real estate agents, constrution workers, and other independent contractors. The City of Cynthiana requires employers to withhold 1.5% on all compensation paid to employees. For more information. contact the Cynthiana Finance Department: Phone: 859-234-2180. Commonwealth of Kentucky

All businesses in Kentucky must also file with the Secretary of State. Visit www.onestop.ky.gov.

Net Profits Tax:

Net Profits Tax: Assessed at 1.5% of net profits for both the City of Cynthiana and Harrison County for a total of 3.0%.

City and county clerk offices will assist you in completing all required licenses.

Step 6: Rental License (if applicable)

If you plan to rent out residential or commercial property, or if you're operating an Airbnb or VRBO, you will need a rental license with both the city and county.

Step 7: Waste Management and Recycling Plan

Businesses are required to have an effective waste management and recycling plan in place. If your business is a new construction or undergoing substantial renovations, your waste disposal plan must be in place before opening.

- Contact the Harrison County Solid Waste Coordinator if your business is located outside of city limits: Phone: (859) 298-2149

Step 8: Ribbon Cutting and Grand Opening

Once you're ready to open, the Cynthiana-Harrison County Chamber of Commerce would love to help you celebrate with a ribbon-cutting ceremony.

- Obtain your EIN# and open bank accounts.
- Follow this 8-step guide to obtain all permits and business licenses.
- Discuss your business plan and location with the P&Z staff
- Secure purchase/lease at desired location.
- Secure and complete any additional permits, including the health department and ABC licenses.
- Secure sign permits with the planning office BEFORE you order any signage.
- Join the Chamber of Commerce.
